Shaping Our Children's Futures, Together

Messages from Mr Day

The school was filled with Rock royalty on Friday as children took part in our first TT Rockstars day of the year. Children dressed as their favourite rock legends and took part in a day of activities designed to strengthen and embed their knowledge of timestables. Year groups battled it out in different arenas as they competed to become the ultimate rockstars, mastering and demonstrating their knowledge and speed of timetables up to 12×12 .

It was such a wonderful day of learning and a pleasure to see how enthusiastic children and staff were in embracing the theme. A huge thanks goes to Mr Mills and Miss Ashford for organising such an excellent day and to all the children, staff and families for fully immersing yourselves into the rock and roll lifestyle.

What is TY Rockstars?

To support children to learn and become confident with their multiplication tables, children can use a website called 'Times Tables Rockstars' (TT Rockstars). The website contains lots of games with a rock star theme, which support the children to recall times tables facts and increase their speed when answering these questions.

The children all have their own logins and avatars and earn coins for correct answers so that they can buy their avatar new things. We use TT Rockstars in lessons during the week and also advise children to practise as part of homework (Battle of the Bands).

There are two single player modes to play:

Garage - this is the main mode the children should play. The questions will only come from the times tables that the teacher has set. As pupils start to answer questions, TT Rock Stars works out which facts they take longer on and will give them more of these questions to answer.

 $\it Studio$ - these questions can be anything from 2 x 2 to 12 x 12. TT Rock Stars calculates the mean speed from their last 10 games in the Studio and translates this into a Rock Status.

There are also multi-player modes:

Rock Arena - this allows players to compete against all other members of their Band or Class (their band mates would need to join the same game in order to complete together).

Children will need to master different times tables as they move through the school. Our aim is that: in Year 2, children master 2s, 5s, and 10s; in Year 3, children will master 3s, 4s, and 8s. By the end of Year 4, children will need to have mastered all timestables up to 12 x 12. In June 2024, children in Year 4 will complete the Government's Multiplication Tables Check (MTC), where they will be asked 25 questions and will have to answer each question within six seconds.

If you want to know how you can support your child with their timestables, come along to our workshop on Tuesday 24th October, or speak with their class teacher.

Parent Safeguarding — Risk of Youtube From 'National Online Safety'

What Parents & Carers Need to Know about

YOUTUBE

YouTube is a video-sharing social media platform that allows billions of people around the world to watch, share and upload their own videos with a vast range of content – including sport, entertainment, education and lots more. It's a superb space for people to consume content that they're interested in. As a result, this astronomically popular platform has had a huge social impact: influencing online culture on a global scale and creating new celebrities.

INAPPROPRIATE CONTENT

YouTube is free and can be accessed via numerous devices, even without creating a YouTube account. Some content is flagged as 'age-restricted' (requiring the user to be logged into an account with a verified age of 18), but children can still view some mildly inappropriate material. This can include protanity and violence, which some young users may find upsetting.

CONNECT WITH STRANGERS

YouTube is a social media platform which allows people to interact with other (usually unknown) users. Account holders can leave comments on any video they have access to, as well as messaging other users directly. Connecting with strongers online, of course, can potentially lead to children being exposed to adult language, to cyberbullying and even to encountering

SUGGESTED CONTENT

YouTube recommends videos related to what the user has previously watched on their account, aiming to provide content that will interest them. This is intended to be helpful but can also lead to binge-watching and the risk of screen addiction, especially if 'auto-play' is activated. Users without an account are shown popular videos from the last 24 hours, which might not always be suitable for children.

HIGH VISIBILITY

Content creators can also be put at risk – especially young ones who try to make their online presence as visible as possible. Creating and uploading content exposes children to potential harassment and toxicity from the comments section, along with the possibility of direct messaging from strangers. Videos posted publicly can be watched by anyone in the world.

TRENDS AND CHALLENGES

YouTube is teeming with trends, challenges and memes that are fun to watch and join in with. Children often find these immensely entertaining and might want to try them out. Most challenges tend to be safe, but many others may harm children through either watching or copying. The painful 'salt and ice challenge', which can cause injuries very quickly, is just one of many such

SNEAKY SCAMMERS

Popular YouTube channels regularly have scammers posing as a well-known influencer in the comments section, attempting to lure users into clicking on their phishing links. Scammers impersonate YouTubers by adopting their names and profile images, and sometimes offer cash gifts or 'get rich quick' schemes. Children may not realise that these users are not who they claim

Advice for Parents & Carers

APPLY RESTRICTED MODE

Restricted Mode is an optional setting that prevents YouTube from showing inappropriate content (such as drug and alcohol abuse, graphic violence and sexual situations) to underage viewers. To prevent your child from chancing across age-inappropriate content on the platform, we would recommend enabling Restricted Mode on each device that your child uses to access YouTube.

CHECK OTHER PLATFORMS

Influential content creators usually have other social media accounts which they encourage their fans to follow. Having an open discussion about this with your child makes it easier to find out how else they might be following a particular creator online. It also opens up avenues for you to check out that creator's other channels to see what type of content your child is being exposed to.

TRY GOOGLE FAMILY

Creating a Google Family account allows you to monitor what your child is watching, uploading and sharing with other users. It will also display their recently watched videos, searches and recommended videos. In general, a Google Family account gives you an oversight of how your child is using sites like YouTube and helps you ensure they are only accessing appropriate content.

MONITOR ENGAGEMENT

YouTube is the online viewing platform of choice for billions of people, many of them children. Younger children will watch different content to older ones, of course, and react to content differently. You may want to keep an eye on how your child interacts with content or YouTube — and, if applicable, with content creators — to understand the types of videos they are interested in.

CHECK PRIVACY SETTINGS

YouTube gives users the option of uploading videos as 'private' or 'unlisted' – so they could be shared exclusively with family and friends, for example. Comments on videos can also be disabled and channels that your child is subscribed to can be hidden. If your child is only uploading videos that are protected as 'private', they are far less likely to receive direct messages from strangers.

LIMIT SPENDING

Although YouTube is free, it does offer some in-app purchases; users can rent and buy TV shows and movies to watch, for example. If you're not comfortable with your child purchasing content online, limit their access to your bank cards and online payment methods. Many parents have discovered to their cost that a child happily devouring a paid-for series quickly leads to an unexpected bill!
